CONSENT FOR MEDICAL TREATMENT OF MINORS

The purpose of this consent is to permit the treatment of minors who become ill or injured when the parents or guardians cannot be reached to give consent for treatment. Every reasonable attempt will be made to contact the parents or guardians listed above.

I, the undersigned Parent or Guardian of the above named minor, do give my consent and permission for him/her to participate in events sponsored by Normandy United Methodist Church. In the event of injury or illness to the above named minor, I, the undersigned Parent or Guardian, hereby authorize an adult leader of the Normandy United Methodist Church to secure, and any physician in attendance to provide, such emergency medical treatment as shall be deemed necessary by those present; including but not limited to hospitalization, injections, anesthesia, surgery, x-ray, blood, and medications. I understand that every reasonable effort shall be made to contact me or the emergency contact at the phone numbers listed above prior to medical treatment.

Normandy United Methodist Church does not maintain any medical insurance for participants in activities. I understand that we will be responsible for any and all costs of medical treatment incurred by or on behalf of the above named minor.

COVENANT OF BEHAVIOR

Participants in events sponsored by Normandy United Methodist Church are expected to abide by the following standards of behavior at all times without exception:

You may not bring or use the following substances, regardless of your age: tobacco products, alcoholic beverages, illegal drugs or similar substances intended for “recreational” use, guns, weapons, or fireworks. You may also not create, view, or distribute pornographic, inappropriate, offensive, or abusive material. If in doubt, ask.

Your behavior, including your speech and actions, must reflect Christian values and respect for others. Criticism and complaints must be expressed in a constructive manner. Illegal acts, including theft and destruction or vandalism of others’ property, will not be tolerated. Disagreements will be addressed with words; fighting is not acceptable. Sexual advances or “public display of affection” are not appropriate.

You are expected to follow the rules of the Normandy United Methodist Church and those of any location or organization visited. You are required to obtain permission from an adult before leaving our group or leaving the site or location our group is visiting. You are expected to be on time for all scheduled activities and check-ins.

Visiting the room or area of a person of the opposite sex on trips involving an overnight stay is strictly prohibited without the permission of an adult leader.

Report injury or illnesses promptly to an adult.

In signing this covenant, I understand and intend to follow these standards and expectations. Should I fail, I agree to accept responsibility for my actions. Violation of any portion of this covenant results in consequences, including the possibility that my parents may be called and required to transport me home at their expense.
